2. APPROVAL OF MINUTES –

Approval of minutes from the June 15, 2017 regular meeting.

Motion: Commissioner Davison moved to approve minutes from the June 15, 2017 regular meeting. Motion was seconded by Commissioner Gomez. Voice vote reflected unanimous approval.

4. NEW BUSINESS

A. Election of Commission Chair and Vice Chair Person

Discussion took place for nomination of commission chair and vice chair. Commissioner Jacobs declined commission chair position. Commissioner McKaig accepted nomination for chairperson. Commissioner Flores accepted nomination for vice chairperson.

Motion: Commissioner Flores moved to appoint Commissioner Janette McKaig as the Parks and Recreation Commission Chair Person. Motion seconded by Commissioner Davison. Voice vote reflected unanimous approval.

Motion: Commissioner Gomez moved to appoint Commissioner Frank J. Flores as the Parks and Recreation Commission Vice Chairperson. Motion seconded by Commissioner Davison. Voice vote reflected unanimous approval.

B. Recommendation for location of 9/11 Survivor Tree

Director Tickemyer went over the background information of the 9/11 Survivor Tree. A tree survived the 9/11 attack and seedlings have been taken from the tree to be given to a community that have endured a tragedy. In 2016 a seedling was given to San Bernardino in memory of the incident on December 2, 2015.

*Proposed sites for the tree are:
Hernandez Community Center
City Hall Campus (2 areas)
Police Department*

Commissioners discussed the pros and cons of each site. The consensus was Hernandez Community Center since this was the home base for families wanting to know about loved ones as well as the home base for new organizations and public figures.

Motion: Commissioner Davison moved to recommend Ruby C Hernandez Community Center as the site for the placement of the 9/11 Survivor Tree and Memorial Plaque. Motion was seconded by Commissioner McKaig. Voice vote reflected unanimous approval.

C. Commissioner Update on Major Park Concerns

Commissioner Davison questioned about the condition of the wall at Ronald Reagan Park and the reports of damage caused by vandalism.

Director Tickemyer advised that he did a comparison of the condition of the wall now versus when originally installed and it appears to be in exactly the same structural condition. He has been in touch with Friends of Ronald Reagan Park and the original muralist has offered to update the mural when it is needed.

Commissioner Davison inquired about talk regarding a shade structure at Ronald Regan Park in the comer. Director Tickemyer advised that if a shade structure were to be installed the location would me more suited to the middle of the park. Comer area is not a good location.

Commissioner Gomez questioned about status of lights at Nunez Park in the basketball court. States kids use the area well as dark and there is not adequate lighting.

Director Tickemyer advised that a part-time electrician was added to the department staff about 2 months ago. Right now they have him addressing safety issues within the parks. The 6 lights remaining at Nunez Park will be addressed in the future, but at this time the 2 missing cannot be replaced.

Commissioner Gomez gave kudos to department and staff for improvements at La Plaza Park.

Commissioner McKaig inquired about the dead tress at Perris Hill Park. Director Tickemyer explained that the city has over 300 identified dead trees located throughout the city. The department is responsible for trees located at city parks. Trees that pose a safety hazard will be addressed first remaining trees will be addressed throughout the year as the budget allows.
